**UPDATE ON THE OPERATIONAL AVAILABILITY PLANNED AT EACH TRANSNET PORT TERMINAL DURING THE COVID-19 LOCKDOWN**

Further to the Transnet Group communique number 3, dated 03 April 2020 (attached) the purpose of this letter is to update you with regard to the level of operations, which Transnet Port Terminals (TPT) is currently planning at each of our terminals.


