WORKERS ARE ENCOURAGED NOT TO COME TO WORK WHEN ANY OF THE COVID19 SYMPTOMS ARE EXPERIENCED

 AND ABOVE
- COUGH ANY COUGH
- SHORTNESS OF BREATH
- HEAVY BREATHING
- FATIQUE

PERSON MUST BE REMOVED FROM WORKPLACE AS SOON AS POSSIBLE WITHOUT ANY CONTACT WITH OTHERS OR WORK SURFACES. ARRANGE TRANSPORT FOR THE WORKER – AVOID FURTHER CONTAMINATION

DISINFECT EMPLOYEE'S WORK AREA & ALL SURFACES THAT THE INFECTED EMPLOYEE HAS COME INTO CONTACT WITH:

- ALL SURFACES AND OBJECTS VISIBLY CONTAMINATED WITH BODY FLUIDS/RESPIRATORY SECRETIONS
- ALL POTENTIALLY CONTAMINATED HIGH-CONTACT AREAS SUCH AS TOILETS, DOOR HANDLES, AND TELEPHONES
- USE ALCOHOL-BASED SANITIZERS / SURFACE DISINFECTANTS

IF TEST IS NEGATIVE WORKER SHOULD REMAIN HOME TILL 24 HOURS AFTER SYMPTOMS DISAPPEARED WHEN THEY CAN RETURN TO WORK

PERSON CAN **RETURN TO WORK** AFTER 2ND NEGATIVE PCR TEST (AT LEAST 24 HOURS APART) OR 14 DAYS AFTER SYMPTOMS DISAPPEAR

PERSON SHOULD **SEEK MEDICAL**
