FRUIT LOGISTICA

Next week the fresh produce world descends on Berlin to attend Fruit Logistica 2024. Billed as the greatest fresh produce show in the world, the energetic buzz of thousands of fresh produce enthusiasts is definitely a highlight of the year. It reminds one of a rugby match: on the pitch it is brutal as deal makers thrash out final arrangements for the 2024 season, but off the pitch the amber liquid flows and friendships are rekindled. It looks like 2024 will be throwing up a number of new and old variables. Shipping lanes are impacted by the Red Sea unrest (affecting the Suez Canal), while the Panama Canal addresses water challenges. The world is still in a perilous state as the Ukraine invasion continues, and the Gaza conflict rages on; simmering tensions continue in other parts of the world. Add to that rising input costs impacting food security, the state of the global economy with many having lower disposable incomes, energy challenges, continued climate change risks with an increased occurrence of devastating weather events, to name a few. With these macro-economic conditions in the background, fresh produce traders will need to negotiate carefully so as to keep food affordable, while at the same time ensuring that those who produce the food, have sufficient return to stay in business.

The CGA will be representing southern Africa's citrus growers in Berlin, making sure we stay connected and informed while forging profitable partnerships.
