## **NEW APPOINTMENTS AT THE CGA**

Over the past few months CGA has interviewed candidates for two positions as Market Access Liaison Officers. In 2023 the CGA Board resolved to introduce these two positions to strengthen CGA's role in the diplomatic/political side of market access. The CGA invests heavily in research and technical aspects of market access (through the Citrus Research Trust), but it is in the political area that market access applications and progress sometimes gets stuck. These two positions would support Deon Joubert (USA and EU) and myself (Asia, East Europe and Middle East) in the work we do. The position are also part of succession planning for the future. As such, the two posts would be involved initially in desk-type research, while building up a network and abilities over time.

One of these posts has been filled, with Jana Janse van Rensburg having started on 1 July 2024.

In her CV Jana states: I have a great interest in international law and made it part of my academic background since the beginning of my legal studies. Agricultural trading business has become a focus point during my education and compliments my passion for the farming industry in exports as well as the need and urgency for food security. I am currently an LLD postgraduate student at the University of Pretoria. My aim is to make a positive legal impact through my dual research by identifying concerns in the export of produce (using citrus as an example) and innovate a possible solution for better market access for the farming industry of South Africa.

The second post will be filled by Amy Grundling in the middle of August. Amy is presently an intern at the World Trade Organisation in Geneva.

Consequently, I am presently engaged in researching the impact of the African Continental Free Trade Area on the South African fruit industry while concurrently completing my internship at the World Trade Organization (WTO). ## PACKED AND SHIPPED

Inclement weather over the past two weeks has meant further reduction in predicted orange volumes for 2024. The freezing weather in Senwes (Marble Hall and Groblersdal) has meant that the navel estimate in that region has been reduced by 600 000 cartons and the Valencia volumes by one million cartons. The Western Cape (Citrusdal) is still assessing the impact of recent flooding, while the Eastern Cape has been impacted by high winds. The Orange Focus Group will meet next week to update their prediction.
