

CARBON BORDER ADJUSTMENT MECHANISM (CBAM) (PAUL HARDMAN)

As part of the broader European Union Green Deal initiative, the EU CBAM Regulation was published (16th May 2023). Effectively, the CBAM is about taxing parties that import and export goods into and from the EU based on carbon emissions generated in the production and delivery of those goods, less any carbon offsets and carbon sequestrations (carbon sinking) that might have occurred in that reporting period. The CBAM seeks to set a "fair price" for carbon emissions based on the performance of local EU manufacturers of similar products using the Emissions Trading System (ETS). The CBAM will be applied in phases over time. Cement, iron and steel, aluminium, fertilizers, electricity and hydrogen are commodities covered in Phase I. This means companies involved with these commodities will need to start measuring and sharing information on their emissions now, and from 1st January 2026, will be compelled to report annually using the specified EU methodology. The EU Commission expects revenue of 1 billion euro per annum from 2026 to 2030.

Importantly, agricultural products have NOT been included in Phase I or Phase II, and are unlikely to be impacted directly by the Regulation for now. However, buyers of agricultural goods might place significant emphasis on where they source their products from and thus indirectly impact businesses upstream.
